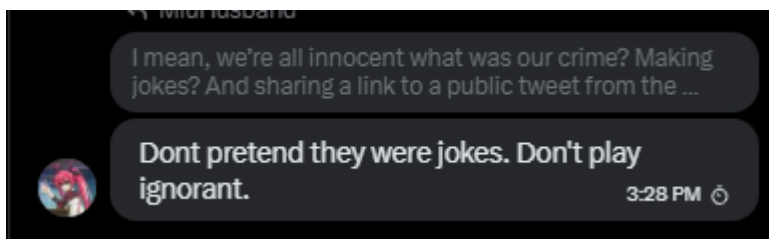
I'm Walker. It's actually pretty nice to meet you - Whether you're a friend, ally or backstabber.

As evidenced by the many DMs I got, lots of people were added to the groupchat a few days ago, without being able to see older messages, and just hanged around without knowing of the sheer malice of the already existent members. As I could see WHEN each member joined, I did manage to see that several of them didn't get to see any of the horrifying messages.

Said people have gotten a lot of harassment - I apologize and will take responsibility for any of it.

This is a consequence of it being a rushed job, which is, too, my fault. **And I'll assume it as much as I can.**

# Debunking the Claims by @CryingEmojiMan.

In this section, I'll debunk several claims made by Bad Blue Archive Memes, also known as @CryingEmojiMan. I'll also analyze the many, subtle fallacies and tactics spread within the thread.

This section will be formatted as such:

**1) Tweet from their thread.**

**2) Opinion:** Here, I will list a personal response toward the arguments, from disproving allegations to calling out @CryingemojiMan and his cabal.

**3) Analysis:** Here, I'll list a more detailed analysis that isn't guided by personal responses/arguments, targeting the text by its letters more than by the fact that it's meant to defame me. It'll bring out its many fallacies and bad-faith arguments.

## Tweet Nr. 1

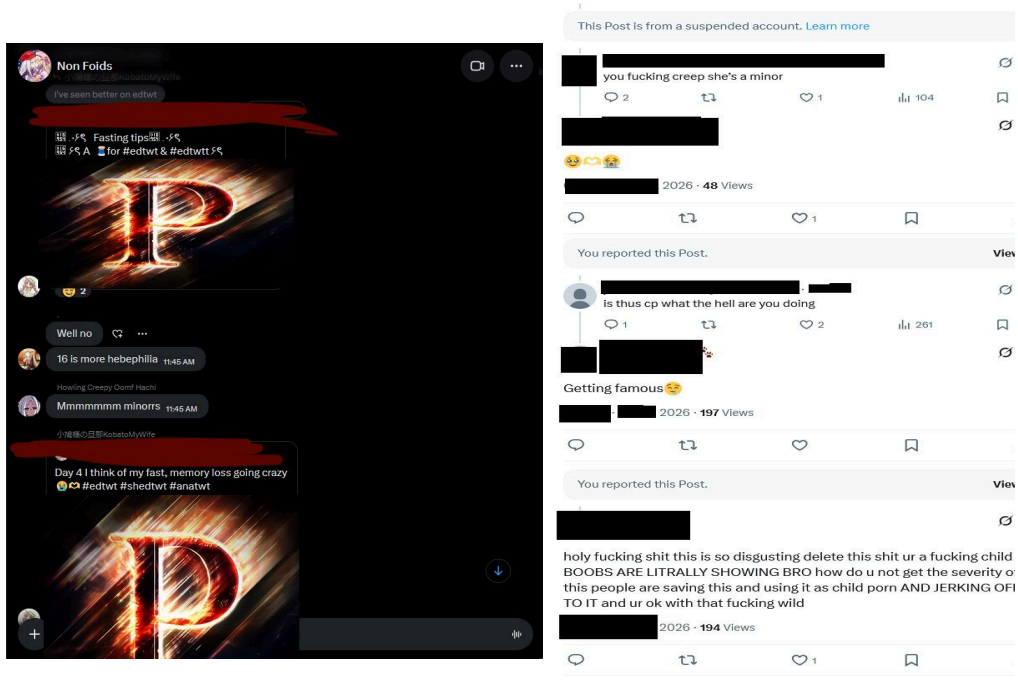


**Opinion:** First of all, this is and has never been a personal vendetta. I myself casually talked and even liked SisCunnyFan before knowing about the GC, as I understood his anti-tourist stance. Yet I don't want adults encouraging minors to cosplay as BA characters, and this led me to delve deeper.

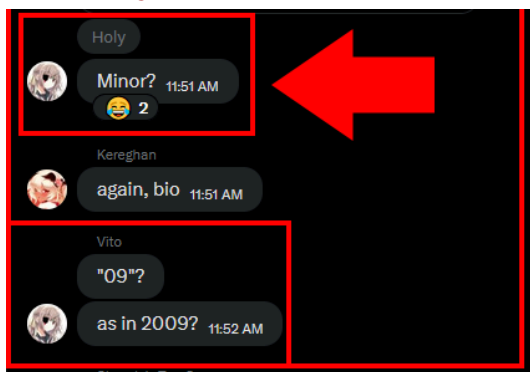
**Analysis:** This is also a case of classic whataboutism and minimization, **something you'll see a lot within this thread.** It doesn't deeply engage with what was allegedly said in the GC, nor debunks the comments within it.

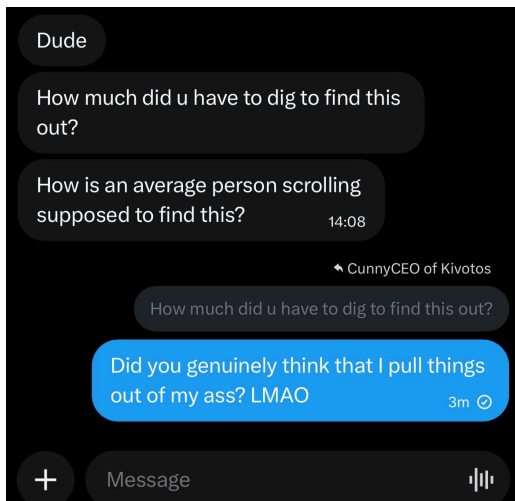
**Opinion:** What even are the "Edgy Jokes"? Gooning to minors on shedtw? Minors whose age can be seen in the screenshots below?



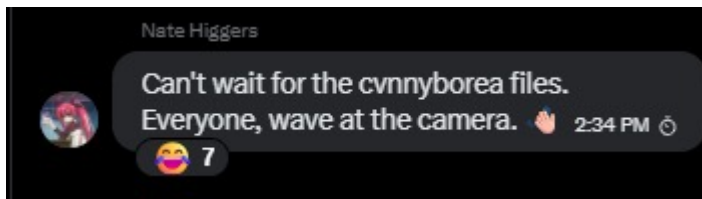
**The post that GC shared had comments.** Comments which pointed out that she was a minor, and comments which did ratio her post. You most likely read the comments - Especially if it's shedtw, which is a red flag as it's KNOWN for having minors in it. **And if the GC has shown itself able to read minors' bios whenever they post them, then they most likely can read the comments too.**



Jokes that CEO had to delete since they counted as CSEM, for he posted an uncensored screenshot of a fourteen year old? **If those on the GC had to delete the “Jokes”, then they most likely weren’t jokes, and you’re simply trying to save face.**



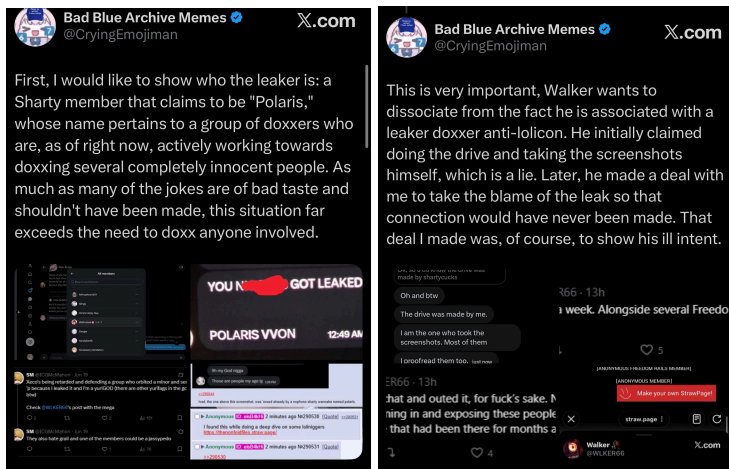
But hey, they were just edgy jokes. It doesn't matter that they were gooning to mentally ill minors, they said "It's a joke chud ~" afterwards and that **immediately scrubs them off of any responsibility.**



I chose to take responsibility in the previous chapter. I'd love to see them do the same. If they ever do.

**Analysis:** This is **guilt by association** and a **false dichotomy** (Sharty bad → content not worth discussing). Even if I had bad motives, screenshots are still accurate.

# Tweets Nr. 2 & 3



**Opinion:** First of all, POLARIS is not a sharty member.

Sharty member that claims to be "Polaris," whose name pertains to a group of doxxers who are, as of right now, actively working towards doxxing several completely innocent people. As

POLARIS is an individual, unaffiliated group which many members of Freedom Rails and Gacha Grail were monitoring. It is a niche, and very little is known about it or its motives.

**Our personal spy chose to LARP as POLARIS, since I didn't want him to LARP as a known group to cause a war. We neither like nor endorse POLARIS, but it would've been better than to LARP as the sharty or KF, which would've started an even bigger conflict. In hindsight, this was wrong, and he shouldn't have LARPed as anyone, and been honest about leaking the GC.**

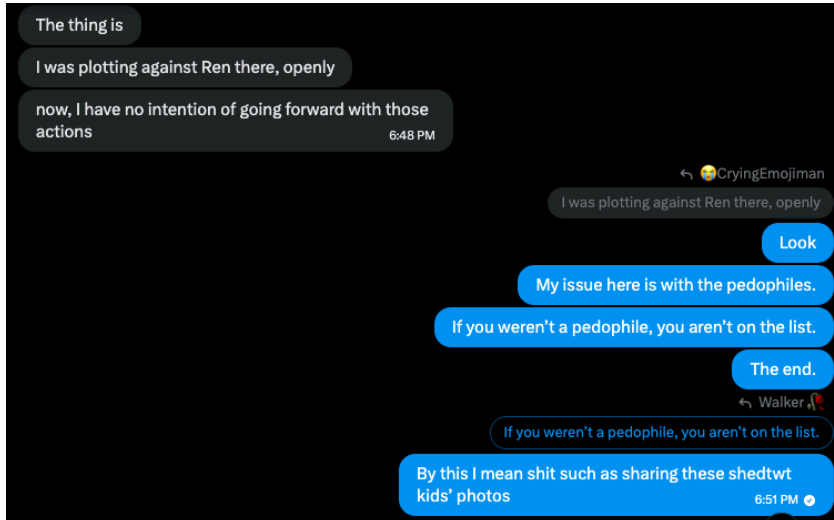

I put you as a collaborator, since you gave me valuable info on some members. I am not retarded enough to make you guilty or something you didn't do, as seen here.

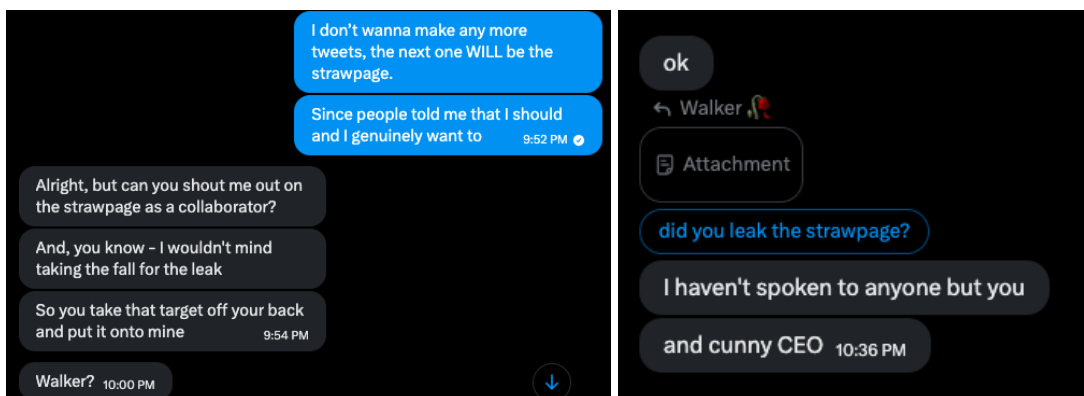
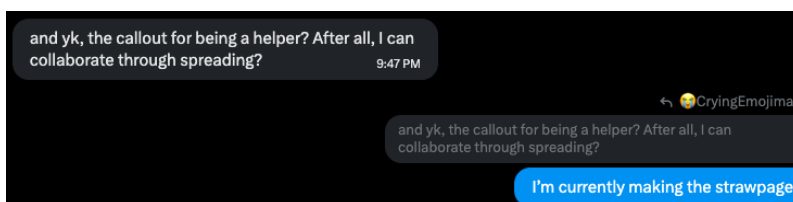
If I told you that you didn't have anything to fear, since you weren't on the list, why would I possibly make you seem guilty when you weren't?

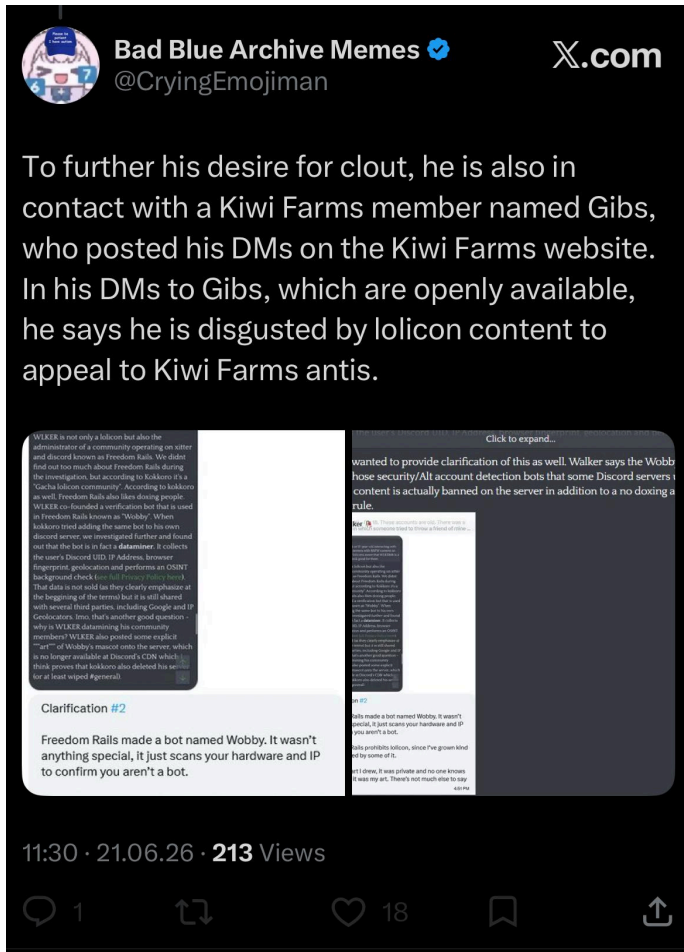

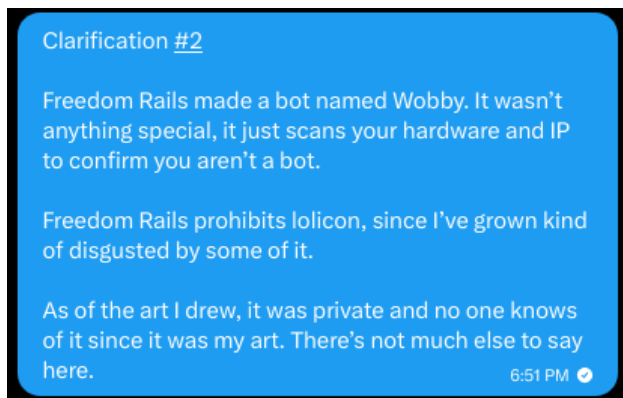
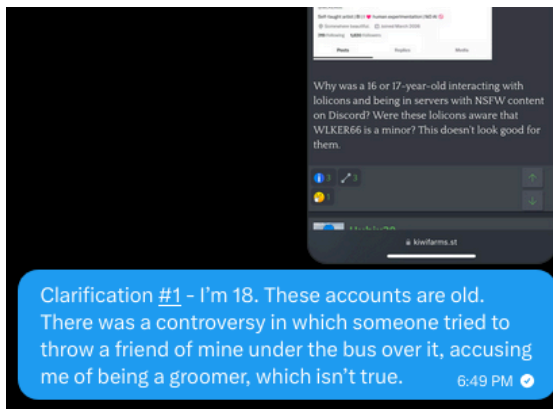


Analysis: I seemingly have to reiterate that this is guilt by association. The tweets themselves don't hold much worth aside from this.

**Opinion:** I told him to make the DMs available. I don't think there is anything discriminating against them. At the same time, you conveniently forgot to post Clarification 1, seen below, which would've ruined your next tweet. You knew what you were doing here.



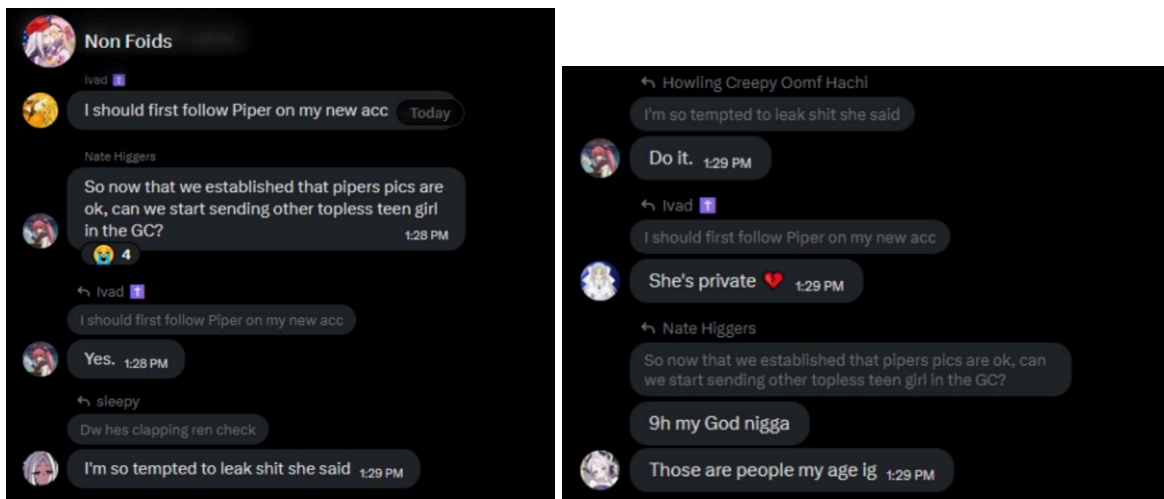
In his DMs to Gibs, which are openly available, he says he is disgusted by lolicon content to appeal to Kiwi Farms antis.

Back in February, some members of some GCs got the idea of making a global channel. Sadly, this didn't work since people started spamming very gross depictions of the content you speak of, involving sex work/illegal activities, **which grossed me out and led to it being pulled out of FR. Lolicon has been forbidden in Freedom Rails since then.**

In the end, a global channel got flooded with stuff I found gross, so it got shut down. That's a moderation/boundary issue, not necessarily an ideological opposition to you.

If I only expressed personal disgust, that's fine. If I used that disgust as justification for leaking DMs/screenshots, allying with KF users, or broader attacks on the community, then it crosses into disruptive behavior. Personal boundaries are valid, and should be respected.

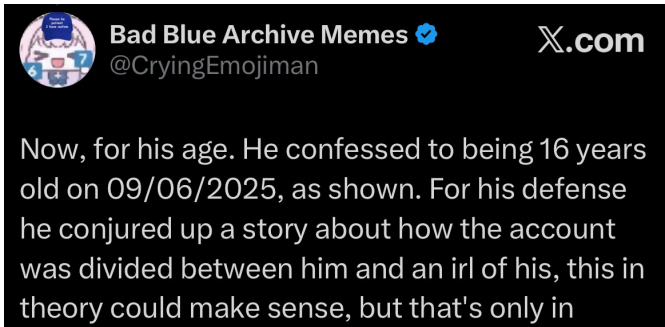
Not only do you misinterpret what an anti even is, but you water it down.

I can't reveal more, since it contains personal info such as my name, address and school district. The small blue line at the bottom of the date is a stamp of my home city, which I won't leak either.

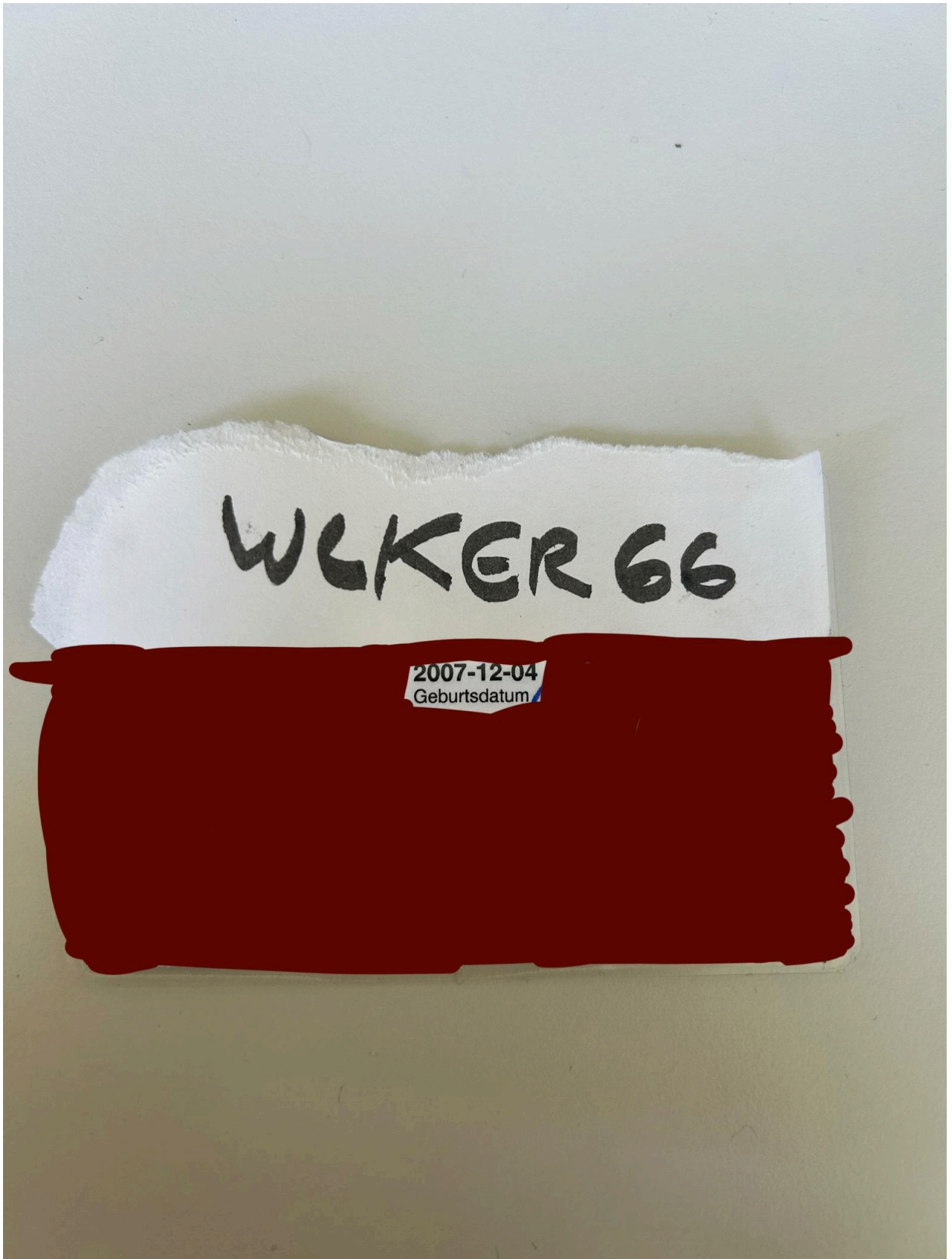

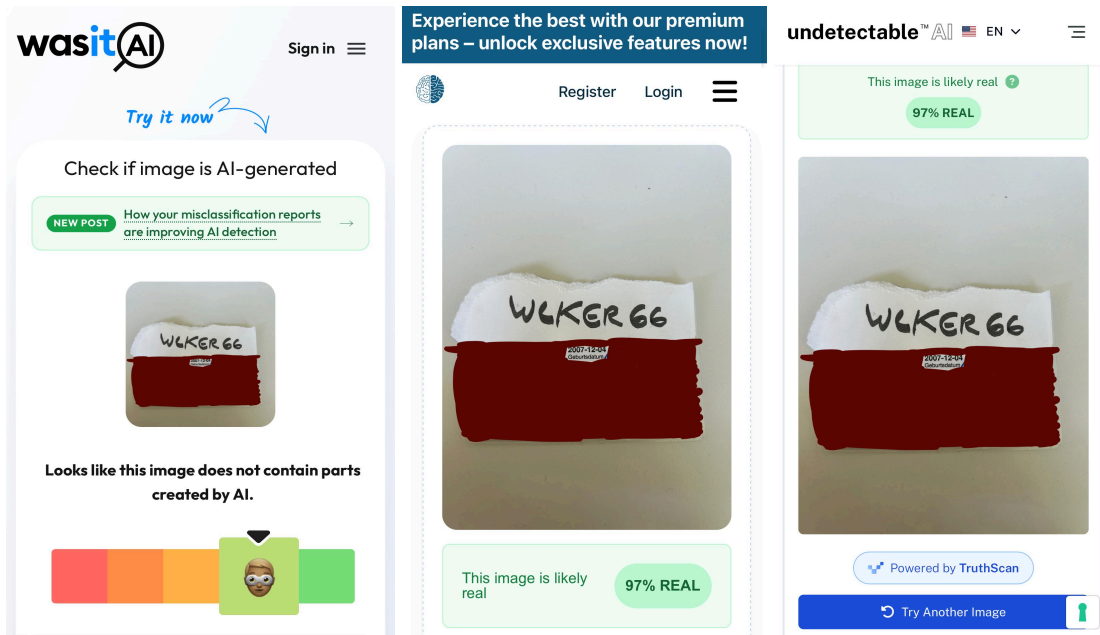

I want you to notice how inputting WLKER64 or WalkerArt64 will bring out a bunch of political tweets. People ratioing me over points I agree with today, such as no immigration. Overly liberal ones, no less. Why is that? **Because we were two people.** I did art, he did mostly schizophrenic rants about politics. But we were happy.

In hindsight, he was retarded. I was, too.

As you may see, it is a real piece of identification and that is my birth date.

Considering the fact that he's very clearly doing all of this for clout, him being a minor would be detrimental for all the attention he could get in the ways he wants, so a lie was very clearly necessary for this whole entire op for him to work.

**And, with all of this in mind, this already should lead to your thread being labeled as misinformation.** You also imply that I made this up for the entire GC-leaking event, which isn't true even if I were to have been a minor, since the screenshot you present was from a time in which the other admin didn't even fathom me becoming a right-wing lolicon.

**Analysis: This is speculative psychologizing/mind-reading (motives, lying for attention). It has some inconsistent standards: the thread defends/edgy lolicon spaces that post minors on a groupchat, and endorses minor cosplayers like Piper, so the next tweet is rather hypocritical. If minors are a "child safety issue" here, broader questions apply to the defended community.**



Anyway, seems like someone on the GC already answered your question:



That begs the question - You support a GC that endorsed a minor cosplaying (Who, by the way, started when she was thirteen), but you also criticize me for saying that my boyfriend getting fucked on stream would be insanely hot?

That question, of course, is up to you to answer.

## Tweet Nr. 8



False age claims aside, this is my mistake. I am not friends with Gibs, although I can sometimes be naive and refer to people as friends. In this case, no, we aren't friends, but we merely speak sometimes. I neither know who he is or have any contact aside from Twitter.

**With all of this in mind, this is simply scummy. This has led me to lose two hundred followers, and to friends blocking me. It has done huge damage to my reputation, over something you have lied to.**

# This is Libel.

Germany has the following laws:

- § 186 StGB ([https://www.gesetze-im-internet.de/stgb/\\_\\_186.html](https://www.gesetze-im-internet.de/stgb/__186.html)) (Üble Nachrede / Malicious Gossip): Asserting or spreading a fact that could degrade someone's reputation, unless it can be proven true. Public dissemination (like a Twitter thread) increases penalties (up to 2 years or fine).
- § 185 StGB ([https://www.gesetze-im-internet.de/stgb/\\_\\_185.html](https://www.gesetze-im-internet.de/stgb/__185.html)) (Insult / Beleidigung): Covers violations of personal honor.
- § 187 StGB ([https://www.gesetze-im-internet.de/stgb/\\_\\_187.html](https://www.gesetze-im-internet.de/stgb/__187.html)) (Verleumdung / Slander): Intentional false statements.

As you said a statement of fact ("He is 16"), it's easier to challenge than pure opinions. I don't need to prove massive financial damages for some remedies (injunctions, retraction, counter-statement). And, unlike in the US, harm to reputation/honor is taken seriously, including emotional/social effects.

Other benefits from your thread, which I have archived, are that it was published to third parties, and that it entails actual harm to my reputation, emotional distress, and lost opportunities - **This drama will inevitably follow me everywhere I go, and I have projects, such as a comic, a dating game, and a game. I have no interest in endless drama, but false accusations that paint me as a minor in this context have real consequences. I have substantially more contemporaneous evidence regarding the group chat activities (including admissions and content involving real minors) than has been provided to support claims about my age.**

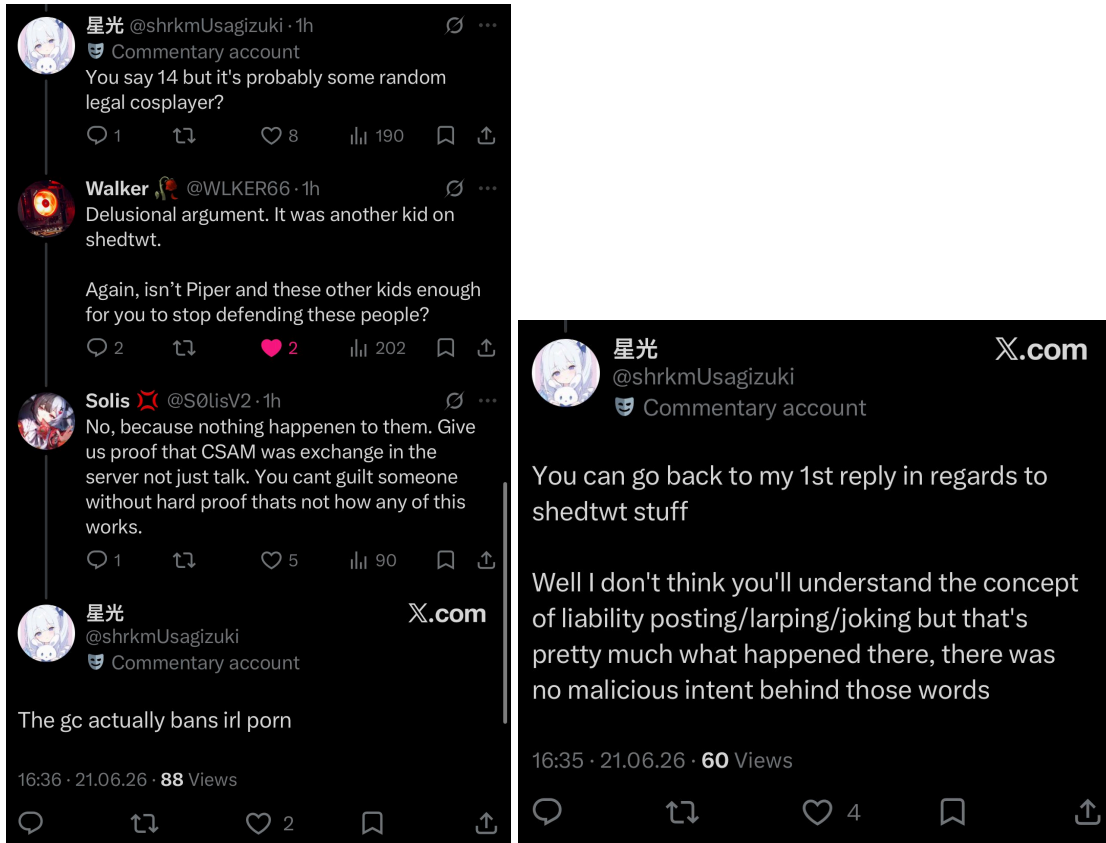
**I believe a public apology, if not multiple since none will get as much attention as your original tweet, is more than deserved in this case.**

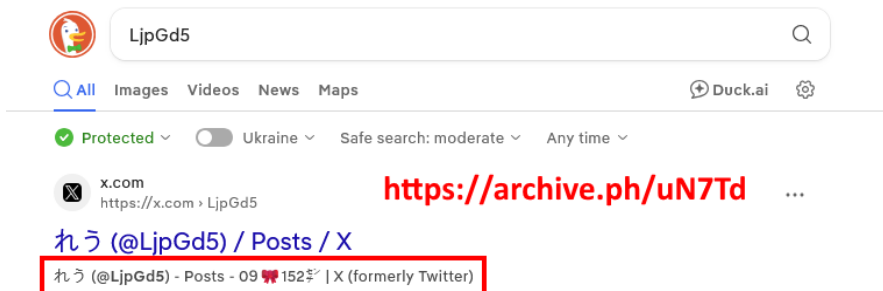
# “It’s not CSEM”

I have gotten a myriad of replies telling me that the photos posted on the GC aren’t CSEM.

Not only is that extremely concerning and ignorant - Since I obviously can’t and won’t show the photos there - but it’s inherently wrong. Here’s why.



First of all, there were other accounts shared other than Piper. Such is the case with @LjpGd5, which was shared by CEO of Kivotos. As seen, the bio **CLEARLY** stated their birth year as 2009.



While most of the links are dead, here are some tweets confirming that this person did, in fact, pose naked.



The most damning evidence against them is the fact that the official account of the Toyama Prefectural Police responded to one of LjpGd5's posts, **declaring that it was CSAM**.

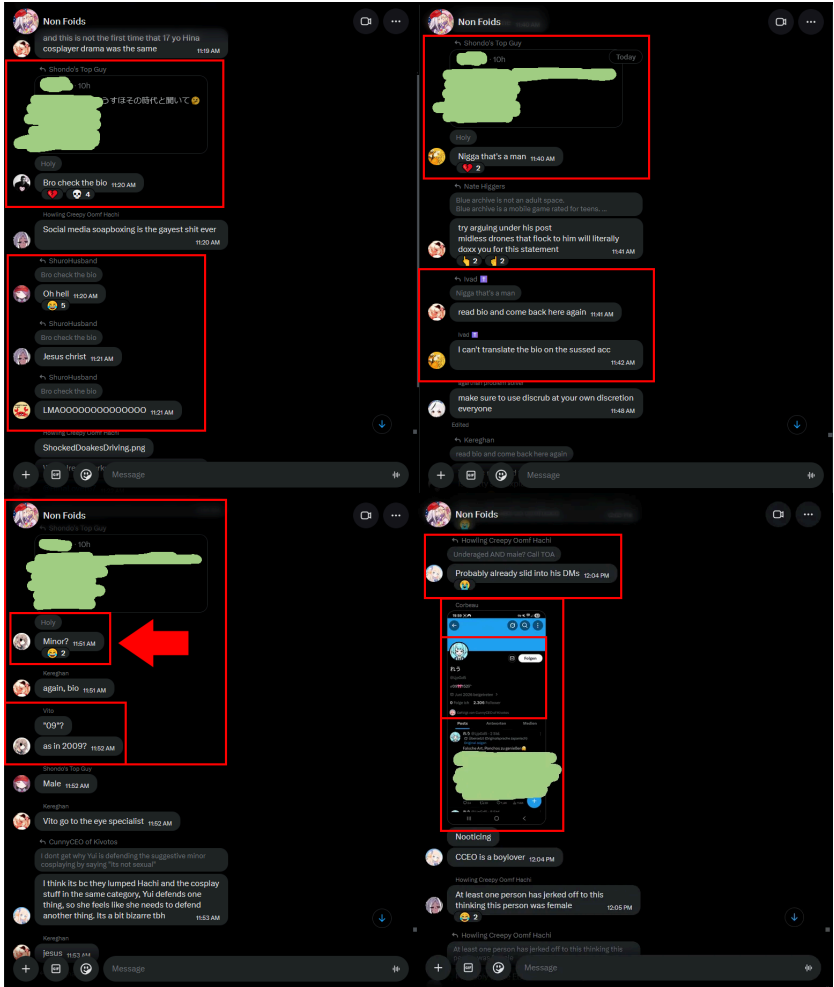
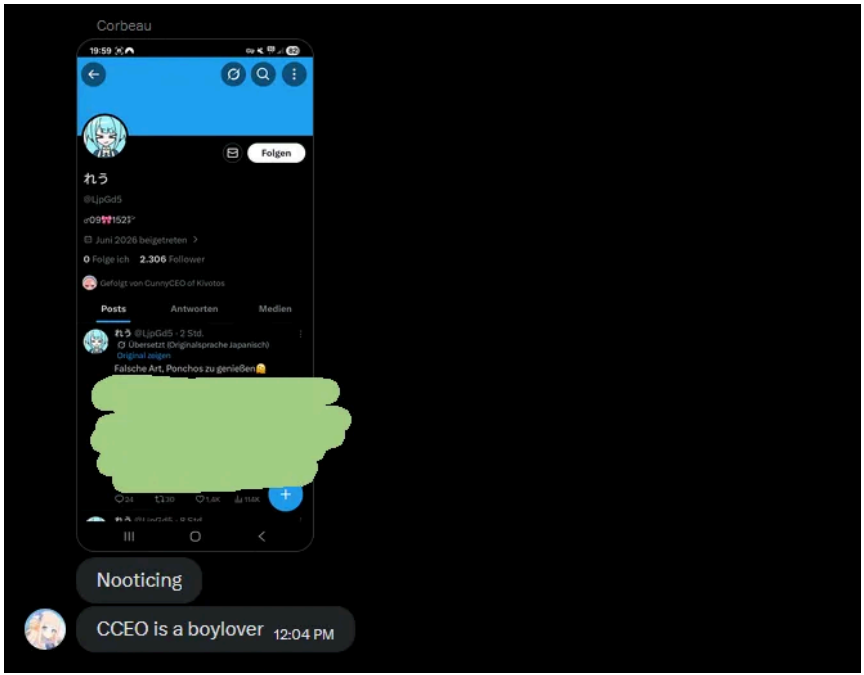

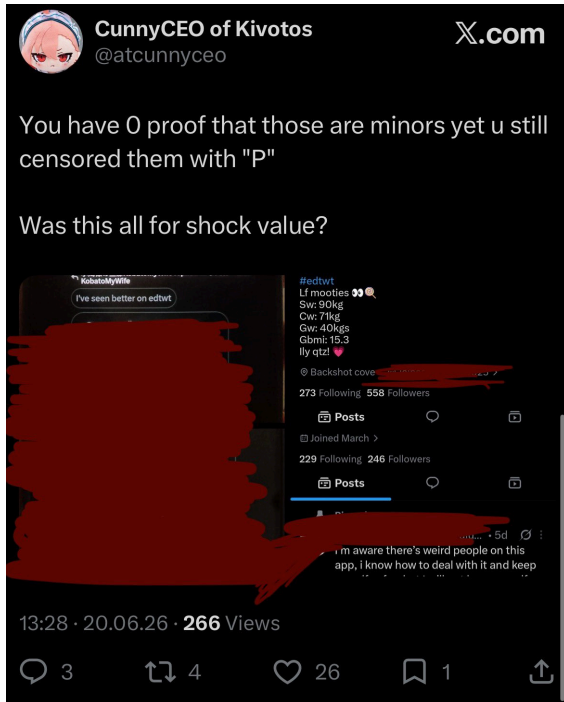

She makes her age rather obvious through her tweets, to which CEO didn't even bat an eye to, which is suspicious, since he **FOLLOWED** her account (Screenshot below)



Not only that, but the GC's members have confessed to reading this girl's bio, including this one, which already tells you all you need to know. **They knew about this.**

The worst part of all is that, when faced with all of these truths, CEO did delete his tweet in which he posted uncensored photos of these girls - Both minors, one of them fourteen. **HE KNOWS it's CSEM. Yet he KEPT defending the GC, and hasn't stopped.**

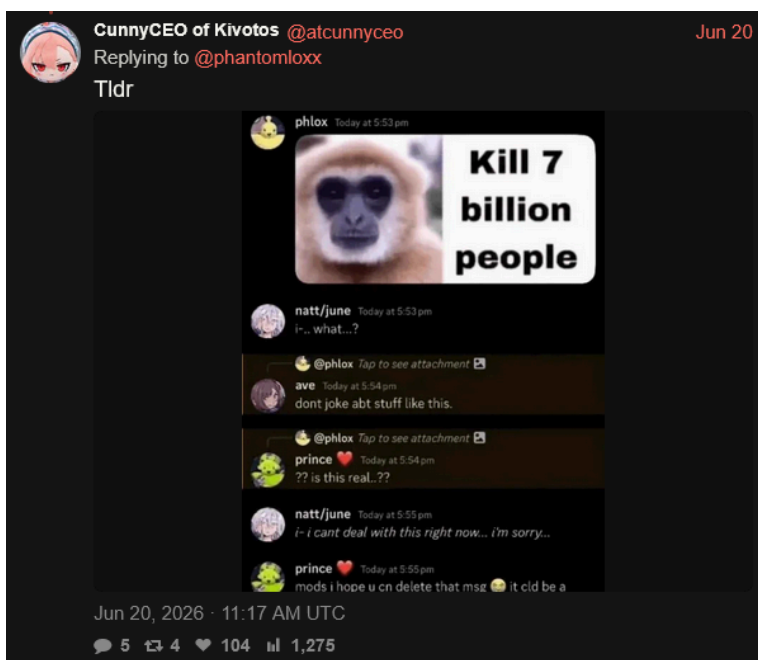

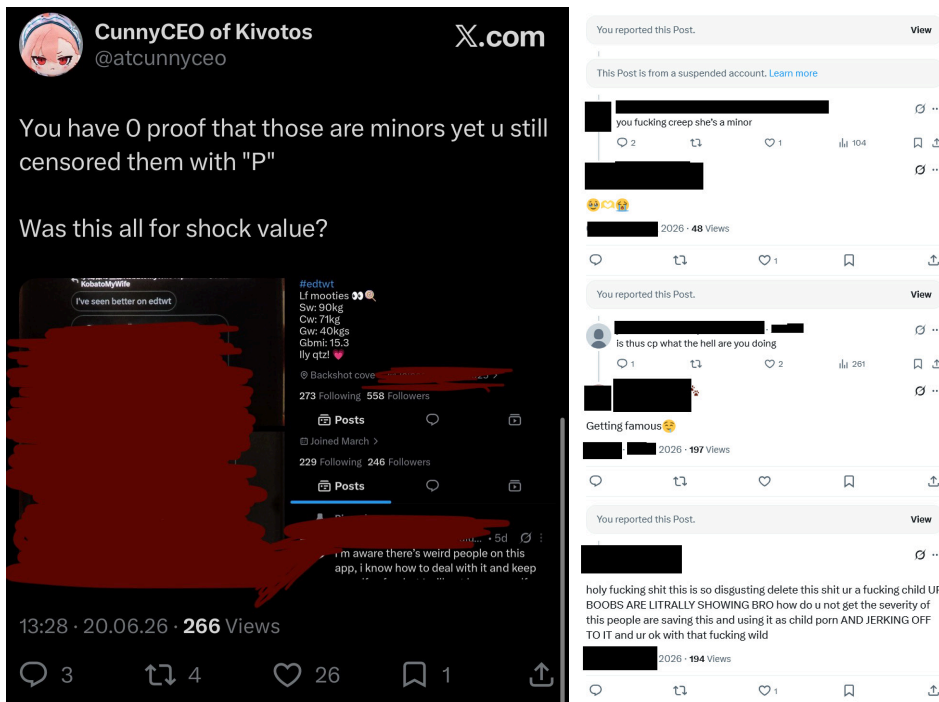

The second account on this doc belongs to a fourteen-year old kid, who was shared into the GC, and later by CEO, who didn't censor her photos.

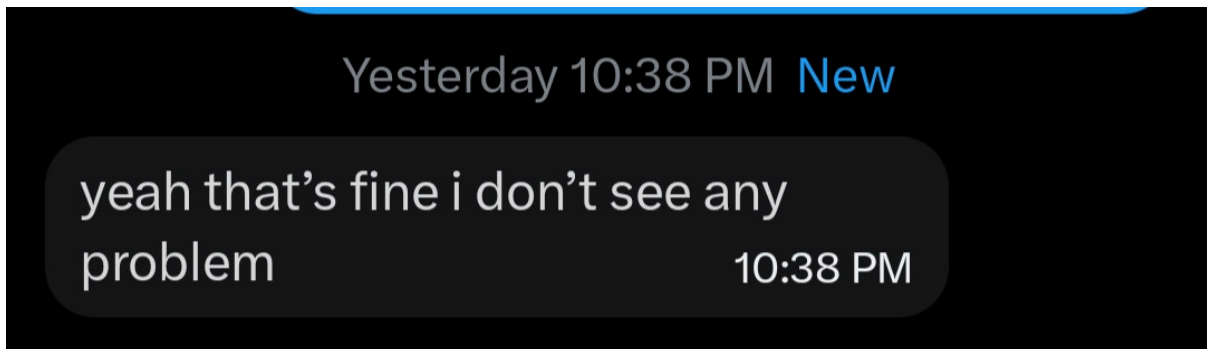


The tweet(s) posted in the GC have been taken down, but their replies already tell that she's a minor. If you're gonna post a childlike person in a GC, and they have **red flags**, such as having edtwrt hashtags, then you **SHOULD** at least look at the post's comments.

We have contacted a friend of said girl, who has clarified to us that she's fourteen.



She also told us that she has no problem with posting these chats as long as we censored her name, which we have.



Here are some more tweets made toward the 14 year old.

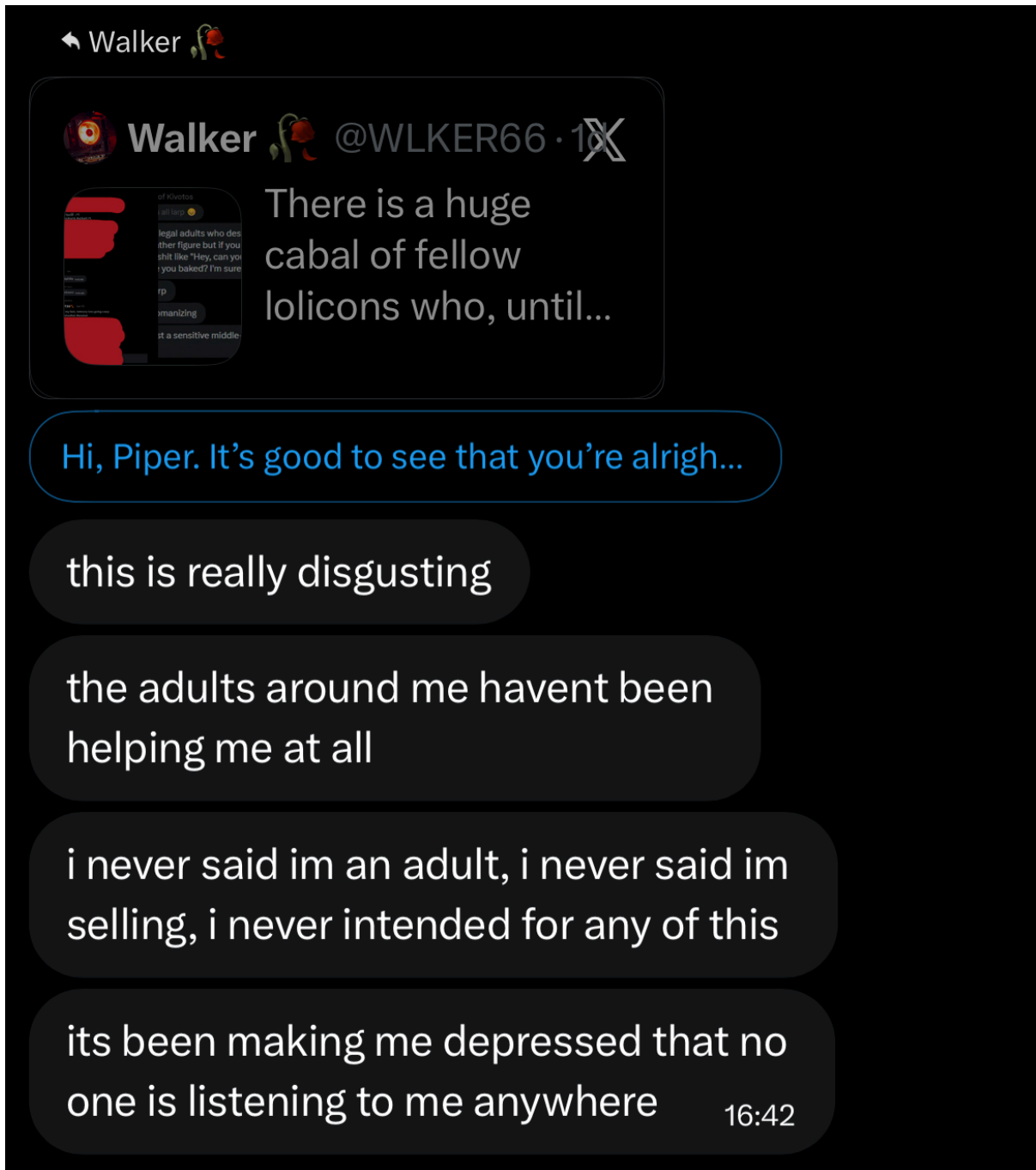

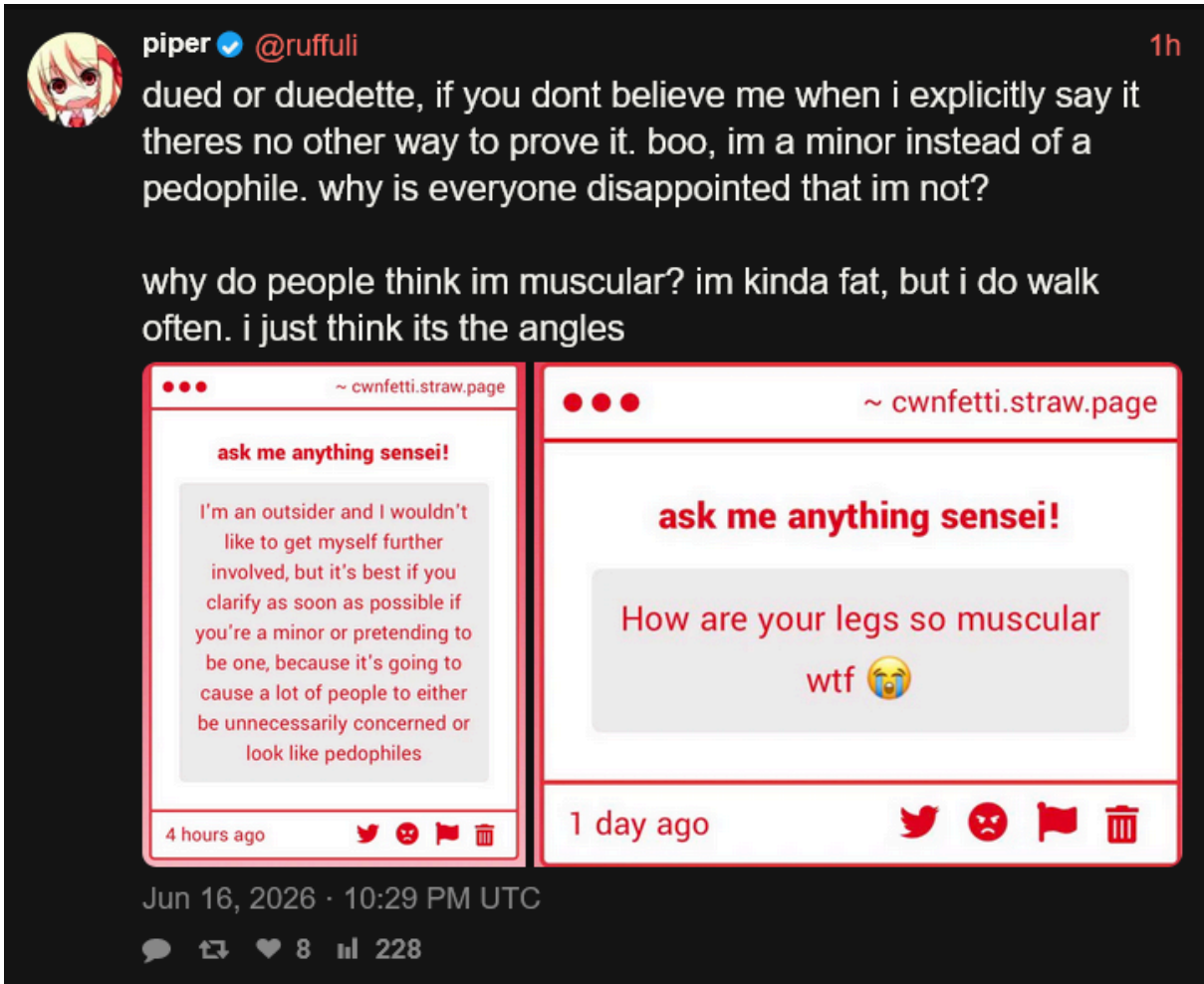

## Lastly, there's Piper.

Piper clearly states that she is "6teen". As of me writing this, both accounts are set to protected mode, for I talked to her and showed her the groupchat's archive. **She was visibly discomforted.**



There is no doubt Piper is 16 as she doubled down on this claim whenever people questioned it. Her birthday is June 14th, which is merely a couple of days ago, and means that she was a 15-year old for most of the GC's existence.



The groupchat, both in its first and second iterations, hoarded Piper's cosplays.



**Federal law (and most states) defines CSEM as visual depictions of minors under 18 in sexually explicit conduct, which includes lewd/lascivious displays focused on genitals, pubic area, breasts, or buttocks, even if clothed or in swimwear if the overall image is sexually suggestive.**

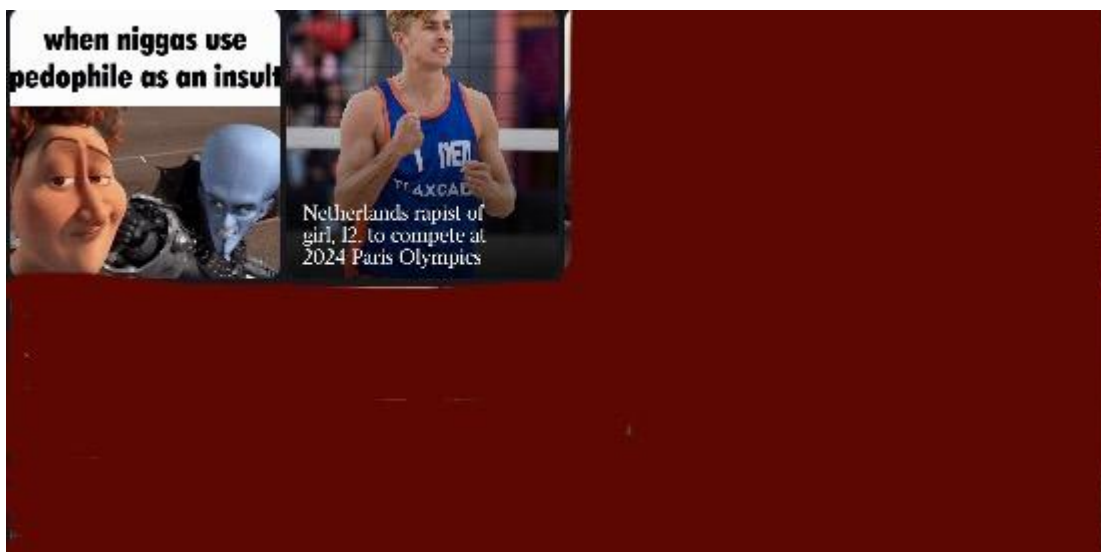
While hoarding non-explicit bikini pictures of a 16-year-old is not illegal, the context, intent, number of images, how they are used/stored/shared, and whether they cross into "lascivious exhibition" or sexual conduct can make possession, distribution, or collection illegal.

And even if Piper's cosplays weren't CSEM, hoarding them after she deleted them out of discomfort is a violation of her privacy/autonomy.



As a matter of fact, "Hoarding" them in a group dedicated to fantasizing about a minor, combined with the chat comments shown in the image (marriage fantasies, age of consent talk, etc.), raises serious red flags for grooming, enticement, or possession with intent that could interest law enforcement. The chat itself demonstrates predatory attitudes toward a child.

**(The red censor covers suggestive photos of her cosplays)**



Another red flag I noticed about Piper is that she wants "a new phone" so her mother doesn't "sus her out."

She was eventually given said phone, probably without her mother's consent. **Mind you, she's 16 since one week ago.**

The fact that a minor has such fans, who are willing to endorse her cosplaying, hoard her cosplays, and help her evade her parents' orders, is suspicious to say the least. And while this doesn't count as CSEM, it certainly is a red flag as of what could be going on in the background.



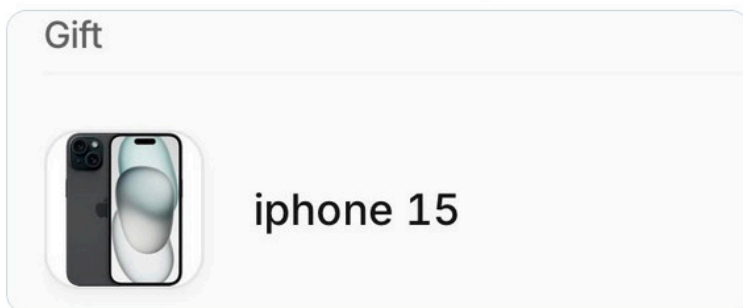

Whether you allow me past the gates or not, I remind you that this will happen again and again. Someone will get too curious and uncover one cabal after another. I hope they do it better than me - And if they don't, that they apologize sooner -, but the consequences will always be your choice as a collective.
