2. The facts supporting this belief are as follows:
On 07/10/2023, **REDACTED** committed the offenses of Stalking First
Degree, RSMo 565.225, Financial Exploitation of an Elder, RSMo 570.145 and
Harassment First Degree, RSMo 565.090.

On 05/01/2023, **REDACTED** contacted **REDACTED** via text message and
stated she wanted ten thousand dollars in cash. I viewed text messages between
REDACTED and **REDACTED** in which **REDACTED** states "I've been thinking about this a
lot, and I've consulted with a few people I trust about it... I decided that I
want you to bring \$10,000 in cash in an envelope to this meeting". The text
message from **REDACTED** states "This is not a joke. This is a test, to
make sure you are acting in good faith and serious about settling this and
working this out with me amicably, and to see if you are capable of following a
simple, straightforward instruction". **REDACTED** continues by stating "I will not
speak to you at all if you don't bring that envelope, and I will ask to see it
myself before we sit down to talk". **REDACTED** has started a website called
DrMuscatoIsAbusive.com, **REDACTED** has made t-shirts and signs also with the
DrMuscatoIsAbusive.com website on it.

On 05/16/2023, **REDACTED** went to speak with their therapist. **REDACTED** was inside
and **REDACTED** was in the parking lot in her vehicle. **REDACTED** approached **REDACTED** and
began to tell her about how narcissistic **REDACTED** was. **REDACTED** had a friend
recording the interaction and posted it on social media. **REDACTED** was asking

REDACTED for money stating she needed money for the care of her cat, REDACTED stated when he got outside REDACTED threw a twenty dollar bill at REDACTED to get her to stop. REDACTED then asked REDACTED about their meeting. REDACTED was talking about the meeting she wanted REDACTED to bring her the ten thousand dollars. REDACTED told REDACTED he did not know about the meeting as REDACTED texted REDACTED about the meeting and would not be attending the meeting without his lawyers. REDACTED did not pay her the ten thousand dollars by June 1st, she would be suing. REDACTED live streamed this incident on her YouTube channel.

On 06/06/2023 REDACTED approached REDACTED while REDACTED was at her dentist appointment. REDACTED dropped off REDACTED at her dentist, REDACTED left to run errands. REDACTED was in the lobby of the building. REDACTED stated REDACTED immediately engaged her stating she needed to speak with REDACTED stated she told REDACTED she had an appointment and would not speak with her. REDACTED stated REDACTED followed her into the dentist office and stated if REDACTED did not speak with her, she would go to the FBI. REDACTED was claiming that REDACTED had child porn on USB drives. REDACTED stated the secretaries asked her if they needed to call 911 or REDACTED stated the secretaries let her back into the office and REDACTED did not try and follow her any farther. REDACTED to have him come to the dentist office. REDACTED told me he went back to the dentist and had to circle the parking lot to see if REDACTED vehicle was there. Both REDACTED and REDACTED were upset and "shaken up" after this incident.

REDACTED told me they have changed the locks on their entire house and they have filed for an ex parte. REDACTED told me all day everyday he is looking over his shoulder waiting for REDACTED to randomly show up around him. REDACTED told me when he does see REDACTED in public, he begins to shake and he is very scared at what REDACTED might do. REDACTED told me that he believes REDACTED has access to his email or his and REDACTED family scheduling app. REDACTED stated there would be no way REDACTED would know we had an appointment at the therapist. REDACTED stated REDACTED has also showed up at places him and REDACTED have went out to eat.

On 06/09/2023, 06/18/2023 and 06/29/2023 to go food orders were made on REDACTED Country Club of Missouri account. The total of these take out orders was \$1089.22. REDACTED contacted a manager at the Country Club of Missouri who was able to identify REDACTED as the person who made the take out orders.
