EMPLOYER'S ORDER TO WITHHOLD FROM EARNINGS FOR CHILD SUPPORT

The Court ORDERS you, the employer of RONALD J. TOYE, Obligor, to withhold income from his disposable earnings from this employment as follows:

Withholding Earnings for Child Support

The Court ORDERS that any employer of RONALD J. TOYE shall begin withholding from his disposable earnings no later than the first pay period following the date this order is served on that employer.

Method of Payment

The Court ORDERS the employer, on each pay date, to remit all amounts withheld through THE TEXAS STATE CHILD SUPPORT UNIT, P.O. BOX 659791, SAN ANTONIO, TX 78265-9791. for distribution according to law. The Court ORDERS the employer to include the following information with each payment: (1) the date of withholding; (2) the number assigned by the title IV-D agency (if available), the county identification number (if available), or the cause number, which is 360-419539-07; (3) RONALD J. TOYE's name; and (4) unless the payment is transmitted by electronic funds transfer, ANDREA L. TOYE's name.

Maximum Amount Withheld

The maximum amount to be withheld shall not exceed 50 percent of RONALD J. TOYE's disposable earnings.

"Arrearage" Defined

As used in this order, the term "arrearage" means the sum of:

1. all past-due child-support and medical-support payments; and
2. all unpaid interest accrued on child-support and medical-support obligations; and
3. all unpaid child-support and medical-support judgment amounts.

Order to Withhold

The Court ORDERS the employer to withhold the following amounts from the earnings of RONALD J. TOYE:

\$460.00	if Obligor is PAID MONTHLY:
	\$460.00 on current support,
	\$0.00 on the arrearage owed, and
	\$0.00 on fees and costs.
\$230.00	if Obligor is PAID TWICE MONTHLY:
	\$230.00 on current support,
	\$0.00 on the arrearage owed, and
	\$0.00 on fees and costs.
\$212.31	if Obligor is PAID EVERY OTHER WEEK:
	\$212.31 on current support,

\$0.00 on the arrearage and
\$0.00 on fees and costs.
\$106.16 if Obligor is PAID EVERY WEEK:
\$106.16 on current support,
\$0.00 on the arrearage and
\$0.00 on fees and costs.

The Court ORDERS the employer to withhold the above amount until MAY 1, 2022.

Calculating Disposable Earnings

The employer shall calculate RONALD J. TOYE's disposable earnings, which are subject to withholding for child support, as follows:

1. Determine the "earnings" of RONALD J. TOYE. "Earnings" means a payment to or due an individual, regardless of source and how denominated, and includes a periodic or lump-sum payment for wages, salary, compensation received as an independent contractor, overtime pay, severance pay, commission, bonus, and interest income; payments made under a pension, an annuity, workers' compensation, and a disability or retirement program; and unemployment benefits.
2. Subtract the following sums to calculate RONALD J. TOYE's "disposable earnings":
 - a. any amounts required by law to be withheld, that is, federal income tax and federal FICA or OASI tax (Social Security) and Railroad Retirement Act contributions;
 - b. union dues;
 - c. nondiscretionary retirement contributions by RONALD J. TOYE; and
 - d. medical, hospitalization, and disability insurance coverage for RONALD J. TOYE and his child.

More Than One Order Withholding

If you receive more than one "Writ of Withholding" or "Employer's Order to Withhold Earnings for Child Support" for RONALD J. TOYE, you shall pay an equal amount towards the current support portion of all orders or writs until each is individually complied with, and thereafter pay equal amounts on the arrearage portion of all orders or writs

until each is complied with, or until the maximum total amount of allowable withholding, 50 percent of RONALD J. TOYE's disposable earnings, is reached, whichever occurs first.

Termination of Withholding

For as long as RONALD J. TOYE is employed by you, you, the employer of RONALD J. TOYE, shall continue to withhold income in accordance with this order until the youngest child reaches eighteen years of age or graduates from high school, whichever occurs last. This order indicates when the child reaches eighteen years of age. Written notice from the child's school of the child's high-school graduation will constitute notice of graduation to you.

Notice of Change of Employment

The Court ORDERS the employer to notify the Court and ANDREA L. TOYE within seven days of the date that RONALD J. TOYE terminates employment. The Court ORDERS the employer to provide RONALD J. TOYE's last known address and the name and address of his new employer, if known.
